# **Red-headed Woodpecker Site Visits Very Productive**

Since our last newsletter, members of our recovery effort team had an exciting visit to Necedah NWR where they met with Rich King. Rich has been involved in establishing oak savannah areas at Necedah and now has 70 nesting pairs of Red-head Woodpeckers. Jerry Bahls, Gary Rathman and Kurt Klusssendorf made the trek to Necedah, saw lots of birds nesting in live oak trees, and had a long talk with Rich about our recovery program. He is very supportive.

Chet and Miriam Meyers traveled to Rutgers Bay Lake golf course where superintendent Joe Wollner graciously loaned them a gold cart to explore the habitat. There are probably three or four nesting pairs on the golf course and this looks like a great place to experiment with nest boxes, as many of the old snags that were present years ago have come down naturally.

Our focus is now on identifying clusters of Red-headed Woodpeckers and doing a state-wide inventory. Craig Mandel has been very helpful in that regard. The word 'cluster' seems more appropriate than colony as these birds are not true colonial nesters. However, if there is good habitat they will use it, as we saw at Necedah. We still need to learn more about the bird and visit these cluster areas to see what we can do to encourage landowners— especially nature reserves, golf courses and cemeteries—to preserve and even create good habitat.
